### **1. Introduction**

Representatives from the European Commission DG RTD and HADEA, project coordinators of six H2020 projects funded in the frame of the call SC1-BHC-29-2020, representatives of European Networks, met for the third annual Urban Health Cluster (UHC) meeting in Bologna, Italy, on 8<sup>th</sup>-9<sup>th</sup> June 2023.

The meeting advanced the urban health agenda through discussions of the technical aspects of urban health research, generating impact through research and innovation, and the translation of these research into urban health policy and action. We reviewed progress over the past 8 months of the cluster and prepared for the next phase of the cluster through workgroup sessions on science translation, health determinants and urban interventions, data protection, urban issues and epidemics, dissemination and communication, and citizen science and urban health.

The following report summarises the presentations and activities conducted, and the main key points.





Contents of the session:

- Alberto recaps the main objectives of the working groups, analysing the following aspects:
  - Identification of relevant target groups at different level. It is done in collaboration with WG5.



- Definition of tools to engage different target groups and most relevant means of communication.
- Identification of the key messages and research findings to be translated at different policy levels.
- The ongoing activities carried on in the working group are:
  - Enhancement of the joint stakeholders list for communication and dissemination. A consent form will be shortly finalised in collaboration with WG5 and WG3.
  - Identification of relevant initiatives and policies that the cluster may impact in a crosssectorial sense. An excel template has been shared among the participant to collect the list of policies and the stakeholder contact.
  - Identification of relevant tools and actions that the six projects are planning to develop in order to engage relevant stakeholders and translate science into policies. This collection is already partially ongoing through the same excel template mentioned before. In addition, Giulia shows the ENLIGHTENme tools aiming at this translating science into policies.
- Points of discussion:

Interaction with stakeholders should not be only "bottom-up" but it should be done in an interactive way organizing policy dialogues and informal communications with policy makers to keep them on board and identify together barriers for the policy implementation. It should not be one-way conversation. There is the need to understand which stakeholders are more active and that reacts to the cluster communication. The project officer Rita can be the contact point to have a link with relevant policy makers in the EU.

Suggestions come from the audience to make the spreadsheet for collecting policies to impact more coherent with UHC topics and indicators collected in WG2

- Next steps:
  - Enriching the stakeholders databases highlighting the stakeholders that are more active and responsive to our communication.
  - Prepare the WG1 workshop in 2024.
  - Decision to connect with other ongoing clusters (e.g. exposome) since many commonalities are highlighted. Attending each other events is the first step.
  - Collection of methods and tools for transferring research into practice actually used by the six projects
  - Keep the WG1 mailing list updated

Contents of session:

Maria Kaselimi (HEART) welcome everybody and presented an overview of the WG4 and the activities carried so far. The following points were highlighted.

- Objectives of the WG4.

- the workshop organized in the 1st annual meeting, in Valencia, dedicated to the topic of urban issues and epidemics and the three invited-speakers, e.g. Nuno Marques da Costa (talk on "Mobility and epidemics in urban environments"); Hande Barlin ("Energy poverty and the impact of Covid-19 pandemic"); and Nicholaos Bakalos ("ICT tools and solutions for pandemic preparedness").

- Cohesion activities and cross-fertilization with other projects, namely STAMINA, COMPRIMME&COMPRI\_MOV; YADES and EUPOLIS).

- Next steps: To do a White Paper on the topic of Epidemics, data and technology

#### Next steps:

- Paulo Morgado (eMOTIONAL Cities) presented the outlines of the White Paper

The white Paper should be a:

> awareness on data gaps and challenges

> a platform for global-interdisciplinary research that is at the nexus of urban health issues, epidemiology and non-communicable diseases



> a 'lessons learn' from the applied and data-driven research conducted by researchers from the UHC

> contribute to efforts to reduce the health economic burden on public health and to adopt a preparedness approach for urban health.

#### Some topics left for open discussion.

> should we adopt a scientific paper format or a guidebook format? The majority of the participants were more in favour of scientific format type.

> what kind of questions we would like to provide an answer through the white paper: a list of questions, organized in four categories were presented for discussion, e.g. 1) data collection & analysis; 2) models, tools & technologies; 3) ethical considerations & data privacy; 4) knowledge transfer to policy recommendations.

> what kind of journal?

> who would be interest to contribute?

> who would be the contact point from each project (it doesn't have to be the, or just, person(s) that were until now signed to the WG4.

#### To get the idea off the ground

Paulo asked the participants in the meeting to send to him and or Maria Kaselimi an email expressing their interest in collaborating on the white paper. And at the same time, an email from the co-coordinators will be sent to all the names in the list of contacts of the WG4 – UHC, presenting the idea of the white paper and how we plan to organize the join collaboration.

#### 5.5. Workgroup 5: Dissemination, Communication & Exploitation

Key points discussed during the session:

- Website and communication materials
  - Cluster website has been updated with the information about the 2<sup>nd</sup> annual meeting and promotional posts were made in the cluster's social media leading up to the event.
  - The 2<sup>nd</sup> newsletter has been published and presentations video from the projects have been uploaded.
  - More people from the project members should follow the Twitter and LinkedIn accounts of UHC.
- We have already done the internal stakeholders list identification. We need more info about external stakeholders. To this end URBANOME and WELLBASED are going to finalize the informed consent document to be distributed together with the stakeholders list.
- Next steps regarding dissemination:



- Apply for Horizon results booster and we have planned to implement this after the summer break. We have to inform the dissemination leaders from each project to join the service and be trained on this.
- will introduce a standardized method to report dissemination and communication activities (example could be the one used for the White Tower forum organized by URBANOME).
- Organise a WG5 meeting in July and the next one in September.
- Next steps regarding exploitation:
  - Create a mini board to gather a list with suggestion about exploitation assets. The matrix has already been shared.
- Thematic workshops:
  - It is important to communicate to the clusters the results of the projects. Thematic workshops could be a good option to engage projects, asking them to present some key results.
- Individual projects' contributions:
  - We also have the policy brief from each project, we can disseminate the policy brief of each project through the cluster. We can prepare other short videos from each project. Another option discussed is to invite UHC members (e.g., Coordinators) to the project's annual meetings and to attract young researchers.
- Newsletters:
  - Also, we decided to increase the frequency of the cluster newsletters (now every 6 months) and to dedicate a short section to the individual projects where they can summarize the main outcomes/activities in that period.
- Joint scientific publications:
  - We should exploiter further opportunities on this direction. We should also communicate open Call for Papers with the rest of the WGs to join efforts!

# 5.6. Workgroup 6: Citizen science approaches to urban health including ethics

#### – Led by ENLIGHTENme / RECETAS

We had an exciting convening of WG6 members with an infusion of new attendees from the EnlightenME consortium, representing academic and policy professionals interested in community engagement and practice-informed research.

The focus of the meeting was to develop an instrument that we will deploy across the Urban Health Cluster to take stock of community participation and co-creation projects happening in each of the consortium and how these processes are advancing the work of each consortium. We discussed the scope of the instrument and a timeline for collecting data and preparing a summary report by end of December 2023.

Additionally, the workgroup was invited to an unveiling in Bologna of a lighting demonstration project. Members were able to see how participation worked to inform the demonstration's design and implementation with members of the community present at the event.
